## Action today can protect you tomorrow - Conference navigating the legal minefield for schools

Townsville Catholic Education will be hosting their bi-annual School Law Conference at the Ville Resort-Casino tomorrow, Wednesday 19 October.

The one day conference focuses on implications of changing legislation, school liability and legislative trends.



The event's keynote speaker, Melinda Tankard Reist is an author, speaker, media commentator, blogger and advocate for young people. She is best known for her work addressing sexualisation, objectification, harms of pornography, sexual exploitation, trafficking and violence against women. Her keynote address will focus on the impact of porn and porn culture on young people and how this exposure can be ameliorated.

Workshop sessions will cover topics such as Family court orders, managing under-performing employees with mental health issues, Vaping, Sexting and other student offences. The event will conclude with a panel Q&A giving attendees the opportunity to ask those important questions.

"Schools are as accountable and responsible as other businesses and organisations are, and must comply with various regulations," said Jennifer Blackshaw, Director of Organisational Services, Townsville Catholic Education.

"We have received feedback from schools telling us how critical school law is, and that it's an area which can cause a lot of angst for staff.
